Grain bin requirements

When you start to plan for a new grain bin, please contact your electric cooperative. We will provide assistance in planning for a safe environment for everyone working and living around grain bins. The State of Iowa requires specific clearances for electric lines around grain bins, with different standards for those filled by portable and permanent augers, conveyors and elevators.


The drawings at the right show the specific clearances required for both scenarios. If you have any questions concerning the drawings, please contact your cooperative listed here.


According to the Iowa Electric Safety Code found in Iowa Administrative Code Chapter 199 -- 25.2(3) b. *An*

electric utility may refuse to provide electric service to any grain bin built near an existing electric line which does not provide the clearances required by the American National Standards Institute (ANSI)C2-2017 "National Electrical Safety Code," Rule 234F. This paragraph "b" shall apply only to grain bins loaded by portable augers, conveyors or elevators and built after September 9, 1992, or to grain bins loaded by permanently installed augers, conveyors, or elevator systems installed after December 24, 1997. (The Iowa Utilities Board has adopted this language.)



Farmers: Stay safe during planting

As farmers make plans to return to their fields for spring planting, your cooperative urges farm workers to be particularly alert to the dangers of working near overhead power lines.

- Always be aware of the location of power lines.
- Be aware of increased height when loading and transporting tractors on trailer beds.
- Remember that electricity can arc or "jump" to conducting material or objects.
- If you hit a guy wire and break it, call the utility to fix it.
- If your equipment does come into contact with power lines, stay in the cab and call for help.
- If leaving the cab is necessary, as in the case of fire, hop to safety, keeping both feet together as you leave the area.

In response to actions by the Iowa General Assembly, your REC has established RECare, a program of members helping members.

RECare will provide funds to be distributed by local community action agencies to help pay winter heating bills and to assist in weatherization of homes of low-income consumers. You may make a one-time contribution or a monthly pledge that will be automatically added onto your monthly electric bill. Even a dollar a month pledge will help others.

Energy Trail Tours postponed to 2022

Out of an abundance of caution and with the health and safety of member-owners in mind, the 2021 Energy Trail Tours have been cancelled. Prairie Energy offers two tour opportunities each summer in partnership with our wholesale power provider, Northwest Iowa Power Cooperative (NIPCO).

"Generation facilities such as Oahe Dam and Powerhouse and Antelope Valley Station, of which both serve as destinations on the annual Energy Trail Tour, remain closed to the public for the foreseeable future," stated NIPCO's tour coordinator Angela Catton. "The decision to cancel the July tours ensures the ongoing health and safety of tour participants as well as employees of the power plants that work in them."



Energy Trail Tours give cooperative member-owners a first-hand opportunity to learn from those directly involved with the process of power generation and delivery. Catton added, "Participants of the tours build lasting friendships with other members of our cooperative family through shared experiences and personal interaction over the course of travelling, together, on a motor coach for three days."

Plans are underway for 2022 with more information to be shared with our membership in January. Energy Trail Tours remain a popular member-engagement activity for our co-op.
